Phara A. Guberman is a leading litigator and partner in the firm's Government Enforcement Defense & Investigations Practice Group. She is based in the firm's New York City office. Phara is a seasoned trial attorney with a practice focusing on white collar criminal defense, government and internal investigations, complex civil litigation, and regulatory compliance.

Phara has successfully handled a wide array of regulatory enforcement and white collar criminal matters, including those involving allegations of corporate and accounting fraud, securities fraud, insider trading, misappropriation of trade secrets, consumer protection issues, cybersecurity issues, and money laundering. She regularly represents clients in court and before the United States Department of Justice ("DOJ"), the Securities and Exchange Commission ("SEC"), the Federal Reserve, state attorney generals, FINRA and other self-regulatory organizations, other federal agencies, and international regulators. Phara also has substantial experience as a business litigator, representing clients in high stakes civil litigation matters in federal and state courts and arbitration proceedings.

Notably, in January 2022, as co-lead counsel at trial and appeal, Phara secured a precedent-setting appellate victory in the Second Circuit in *U.S. v. Connolly, et al.*, where all counts of conviction were overturned against her client, Matthew Connolly, and judgments of acquittal directed. Mr. Connolly's win represents the only LIBOR-related criminal case in the U.S. or U.K. to be overturned on sufficiency of the evidence and has received world-wide attention. The complete appellate victory in *U.S. v. Connolly, et al.* led to Phara's recognition by *The American Lawyer* as its "Litigator of the Week," which also credited the decision as the "second white-collar appellate reversal Kenneth Breen and Phara Guberman...have won in as many years."

The prior year, as co-lead counsel at trial and appeal, Phara obtained a landmark appellate victory in the Third Circuit in *U.S. v. Gibson, et al.*, where all counts of conviction against David Gibson, the former Chief Financial Officer of Wilmington Trust Corporation, were overturned in a matter of first impression, and the two remanded counts were subsequently dismissed. *The American Lawyer* deemed it "a stunning reversal of

criminal convictions for four executives of Wilmington Trust Corp. in a case dating back to the Great Recession.” Phara was nominated twice as *The American Lawyer’s* “Litigator of the Week” for her more than 10 years of work in Gibson.

In 2023, Phara was recognized by *Crain’s New York Business* as part of its Notable Women in Law list and was included among *Bloomberg Law’s* 40 Under 40 honorees. Phara was recently added to *Lawdragon’s* 500 Leading Lawyers in America and 500 Leading Global Litigators guides. She is consistently honored by *Benchmark Litigation* as one of the Top 250 Women in Litigation and by *Global Investigations Review (GIR)* as one of 100 Notable Women in Investigations around the world in the white collar area of law. Her victories have been shortlisted by *GIR* as the Most Important Case of the Year for its impact on future government investigations and wire fraud prosecutions and led to her recognition by *Law360* as a “Legal Lion.” Phara was previously recognized by *Law360* in 2018 as one of five national Rising Stars in White Collar.

Our work in this case was twice nominated by *Global Investigations Review (GIR)* as Most Important Case of the Year for its impact on future investigations and by *Law360* for initially securing a sentencing ruling without any period of incarceration.\*
- Represented David Gibson, former Chief Financial Officer of Wilmington Trust Corporation, in *U.S. v. Gibson, et al.* as co-lead counsel at trial and appeal in a matter involving allegations of accounting and securities fraud brought by the U.S. Attorney’s Office for the District of Delaware. Our client’s conviction was overturned on all counts in a matter of first impression for the Third Circuit and the remanded

counts were dismissed by the District of Delaware. The related SEC litigation was settled favorably. Our victories in this case have been recognized by *The American Lawyer*.\*
